#### PARKS:

### **Pavilions:**

Paul Rork has talked to Apex who is interested in regarding park and will have another quote which will be decided on at the March meeting.

### **Board Member Insurance:**

This was discussed and decided to table this until there were more board members present to vote. Some of the board present will be getting more information from lawyers concerning lawsuits.

## **Term Limits and Voting on Board Members:**

Board is in agreement to get on track with term limits of board members.
