#### PARKS:

Winter Park Grading, Drainage and Grass Seed - Paul Rork has sent out via email a map and quote from Todd's Services for \$21,500 to regrade, add drainage and reseed. Board would like to know if this should be done all at once or can we do it in sections. We also would like to obtain 2 more quotes before making final decisions. There was some discussion on what is our overall goal for Winter Park.

**Storage Shed** – discussed placement around pavilion as we do not want to block vision of any adults watching children on playground from the pavilion. Quotes will be obtained to have the cement slab poured. Slab will be 8 X 12 and apron to be slanted away from door for drainage.

**Insurance** – park insurance was discussed and Board needs to know if the lawn mower has been taken out of the price.

Mike has a quote for \$1026. We will be addressing this at the next meeting.
