MINUTES OF MAY MEETING: motion was made and seconded to approve the April Board Minutes with one minor spelling correction. VOTE: Motion Approved Unanimously.

TREASURER/FINANCIAL REPORT:

Four more residents have paid their overdue dues which leave 10 still unpaid. There was a discussion of a desire to change the late fee from "6% per annum" to a \$25.00 late fee which would be charged if dues are not in by January 31. Motion was made and seconded to vote on amending the by-law from late fees being 6% per annum to \$25.00. **VOTE:**Motion Approved Unanimously. Roxanne will contact Chris about putting this in the newsletter in an article about the voting to amend this by-law as well as any others the Board may desire to change. A quorum of all residents is needed either by their attending the Annual Meeting or by having enough proxies (32 out of 317). Mike Cappuccitti will talk to Rick Pidsosny about the possibility of having an electronic proxy. There was also a discussion about raising dues.

ANNUAL MEETING: the annual meeting is schedule for the third Tuesday of November which means that the meeting would be the week of Thanksgiving. Due to a concern by the Board that this may deter resident from attending, a motion was made and seconded to change the annual meeting date to the second Tuesday, November 14 for just this year. **VOTE: Motion Approved Unanimously.**

PARKS REPORT:

The drain pipe in Winter Park by the pavilion has been cut down. There are a couple of details that have been Over looked that John will address with Executive Landscaping.
