

PAVILION POTLUCKS WINE DOWN FRIDAYS

In the past, an annual picnic open to Parkwood Estates residents has been held. WARNING!!! THIS COULD COST YOU \$80!

No, not the car, the parking job! It is against Canton ordinance to park in a way that blocks the sidewalk. The weather has warmed and out come walkers, parents or grandparents with strollers and small children riding tricycles. There have been several incidents already where sidewalks were block, the resi-



dents were politely asked to move their cars and refused. The result was police were called, came out and an \$80 ticket was given to the residents.

Parking can be at a premium in our subdivision, especially on the courts where there is very limited parking spaces but it is still the residents responsibility to park in a way that does not block the sidewalks. Not only is it inconsiderate of others but there could be potential damage to both humans and vehicles. As always, it is encourage to FIRST TALK to your neighbors face to face or leave a friendly note. If the problem continues, then the only recourse is to call the Canton Police Department and they will come out and give a ticket. The police will not give a ticket out unless someone has called which should tell those who receive a ticket is that they are not respecting the ordinance and are frustrating their neighbors.

Here is a couple of examples of how to park a car so that the sidewalk is still accessible to walkers and bike riders.

LAWN MOWING CONTRACTOR

The Board has approved the contract by J & S Landscaping Service to do lawn mowing for our parks and islands. The contract includes mowing and trimming our three park areas as well as the ten islands for 10,500 for 27 cuttings. Due to government regulations concerning fertilizer, J & S does not do any weed control nor fertilization so the Board is in the process of looking for a company that will. Just a reminder that J & S is **NOT** responsible for trimming around homeowners fencing or landscaping that borders the parks.



TOM BOWDEN CURB APPEAL AWARD

This is our 2nd Annual Tom Bowden Curb Appeal Award which gives all the residents an incentive to spruce up the outside of their house, landscape their front yard and make our subdivision an attractive place for people to live in and drive through. There will be three cash prizes given out for the three homes that receive the most votes. Members of the board will be driving through the neighborhood and voting the last week of June to be tabulated and done by July 1st. Results will be in the September newsletter and on website. Last year's award winners and board members are NOT eligible to receive an award for this year. Areas that will be evaluated include:

House Exterior—siding and paint in good condition, clean, storage of wood, trash cans, etc. seen from front is neat, landscaping material in good condition

Lawn, shrubs and trees—planted, mowed, edged, trimmed, no unhealthy or dead plants



Driveway and sidewalk—edged, in good condition, not broken

Windows—clean, in good condition, not foggy or grids broken, inside window treatments neat



Mailbox—straight, paint or wood finish in good condition, grass trimmed around bottom

Flower—flowers planted would rate higher than no flowers

VEHICLES IN THE PARKS

It has come to the Board members attention that there are residents who are driving their vehicles into our parks **WITHOUT AUTHORIZATION!** Although our parks are open for any resident of Parkwood Estates in good standing to use and enjoy, there are some restrictions as to their use. One restriction is that no motorized vehicle may be driven in any of the parks WITHOUT authorization from a board member. Furthermore, authorization will only be given when conditions are favorable to be able to drive a vehicle in a park without causing any damage to the grounds, equipment or other residents' property. If a resident has driven in any of our parks and has caused damage to the ground such as ruts, then that resident is responsible for repairing the damage. If the resident does not fix the repairs in a timely manner, then the board will hire someone to repair the damage and the costs will be passed on to the resident.
